

## **User agreement on the use of the Internet resource auction.cctld.by**

1. The following terms and their meanings are used in this user agreement (hereinafter referred to as the Agreement):

The Organizer is the Belarusian Cloud Technologies Limited Liability Company, which is a party to this Agreement and the right holder of the Internet resource auction.cctld.by;

Auction - an auction held by the Organizer on an electronic platform located on the Internet resource auction.cctld.by for the right to conclude an agreement on the registration of a second-level domain name, the registration record of which has been canceled in the centralized database of domain names registered in the national domain zone;

User - an individual, including an individual entrepreneur, a legal entity that is a party to this Agreement;

Internet resource auction.cctld.by - an information resource available in the public domain on the Internet, designed to post information about Auctions and holding them;

Personal data - information relating to an identified individual or an individual who can be identified, specified by the User when registering on the Internet resource auction.cctld.by (including before the User joins this Agreement) or provided in another way within the framework of this Agreement;

Credentials - the username and password of the User used for registration on the Internet resource auction.cctld.by, identification when entering the User's personal account and using its functions.

2. This Agreement regulates the relationship between the User and the Organizer (hereinafter referred to collectively as the "Parties") related to the use of the Internet resource auction.cctld.by, as well as the subsystems available on this Internet resource, through which the User is registered, identified during entering the User's personal account and the User's participation in the Auction is ensured.

The conclusion of this Agreement is mandatory for the registration of new Users on the Internet resource auction.cctld.by, the use by Users (including those registered before the conclusion of this Agreement) of the functionality of subsystems located on the Internet resource auction.cctld.by, and participation in the Auction.

3. This Agreement is a public agreement within the meaning of Art. 396 of the Civil Code of the Republic of Belarus (hereinafter referred to as the Civil Code). Posting the text of this Agreement on the Internet resource auction.cctld.by indicates the will of the Organizer to conclude it on the specified conditions with any person who applied and is a public offer to conclude this Agreement.

4. The User concludes this Agreement on the terms of accession to it in accordance with Art. 398 of the Civil Code by performing implicit actions, expressed in filling out the proposed registration form on the Internet resource auction.cctld.by, indicating reliable information about the User and performing all actions necessary for registration on the Internet resource auction.cctld.by, or by putting a mark on consent to join this Agreement in the proposed electronic form when visiting the Internet resource auction.cctld.by.

5. The procedure for holding the Auction was developed by the Organizer and agreed with the Operative and Analytical Center under the President of the Republic of Belarus in accordance with the requirements of the Instruction on the registration of domain names in the national domain zone, approved by order of the Operative and Analytical Center under the President of the Republic of Belarus dated June 18, 2010 No. 47.

The procedure for holding the Auction is posted on the Internet resource auction.cctld.by in the appropriate tab.

By entering into this Agreement, the User confirms that he is familiar with the Auction Procedure, including the responsibility of the Auction Participants, and accepts its terms.

Based on the results of the Auction, the Organizer provides the registrars indicated on the Internet resource auction.cctld.by with information about the User who has acquired the right to conclude a domain name registration agreement, which may contain the User's personal data.

6. The Organizer has the right to make changes and additions to this Agreement unilaterally. Users are notified of changes/additions to this Agreement by posting the current version of this Agreement (with the changes/additions made) on Internet resource the auction.cctld.by no later than the day such changes/additions come into force.

7. The Organizer has the right to process (including provide to third parties) personal data provided by the User under this Agreement. The processing of personal data submitted by the User is carried out by the Organizer for the purpose of concluding and executing this Agreement, including for the purpose of registering the User on the Internet resource auction.cctld.by, identifying the User when entering the personal account, maintaining the User's personal account, ensuring the User's participation in the Auction. The processing of personal data is carried out on the terms determined by this Agreement and in accordance with the Organizer's policy on the processing of personal data posted on the website <https://becloud.by/>, other local legal acts of the Organizer and the law.

The Organizer processes personal data during the term of this Agreement, but not less than three years from the moment the User concludes an agreement for registration of a domain name based on the results of the Auction or a decision is

made to recognize the Auction as void or to cancel the results of the Auction. After the expiration of the period for processing personal data established by this Agreement, the Organizer has the right to continue processing personal data if there are grounds determined by legislative acts.

The Organizer in accessible terms places information about the Organizer's policy on the processing of personal data when organizing Auctions on the Internet resource [auction.cctld.by](http://auction.cctld.by). The User, by entering into this Agreement, confirms that he is familiar with the Organizer's policy on the processing of personal data, including by familiarizing himself with information about the Organizer's policy on the processing of personal data when organizing Auctions.

Each of the Parties is responsible for ensuring that the processing of personal data transferred for the purposes of this Agreement is carried out in accordance with this Agreement, legislative acts and local legal acts adopted in their development that regulate the processing and protection of personal data, including within the framework of legal relations arising from this Agreement.

8. For all issues that are not directly regulated in this Agreement, the Parties shall be governed by the legislation of the Republic of Belarus.

9. This Agreement shall come into force from the date of its conclusion and shall be effective until its termination.

Termination of this Agreement by the User shall be carried out unilaterally by sending to the Organizer through the "Contact Us" section on the Internet resource [auction.cctld.by](http://auction.cctld.by) a notification of unilateral refusal to fulfill obligations under the Agreement no later than 10 days before the date of its termination.

Termination of this Agreement by the Organizer shall be carried out unilaterally by sending the User a notification to the e-mail address specified during registration on the Internet resource [auction.cctld.by](http://auction.cctld.by) about unilateral refusal to fulfill obligations under the Agreement no later than 10 days before the date of its termination.

Upon termination of this Agreement, the Organizer shall delete the User's account on the Internet resource [auction.cctld.by](http://auction.cctld.by).
